1. **Domain Name(s):** We will make a reasonable effort to secure your choice of a domain name(s). However, we cannot guarantee availability. If your choice(s) is not available, we will contact you to request additional names. If you already own your domain name, you must authorize Network Solutions to list CAMPANA SMART SYSTEMS as the technical contact before we can activate your site. *You will be billed \$35 per year for each domain name you own and will be billed either through FrontPageAgent.com or Network Solutions* NOTE: IF DOMAIN NAME REQUESTS ARE REGISTERED THROUGH CAMPANA SMART SYSTEMS, A ONE TIME FEE OF \$25 WILL BE CHARGED TO YOUR CREDIT CARD FOR OUR SERVICES.

2. **Additional Domain Name(s):** You may add domain name(s) that point to your site. There is a one-time \$75 set-up fee, plus \$10 per month, for each additional domain name. *You will be billed \$35 per year for each domain name you own and will be billed either through FrontPageAgent.com or Network Solutions* NOTE: IF DOMAIN NAME REQUESTS ARE REGISTERED THROUGH CAMPANA SMART SYSTEMS, A ONE TIME FEE OF \$25 WILL BE CHARGED TO YOUR CREDIT CARD FOR OUR SERVICES.

3. **Site Design:** We will design the initial setup of your site. Following activation, you will be able to make select design modifications by using your FrontPageAgent.com Control Panel, which allows you to keep your site current. If you would like us to post your photos there will be a per-photo scan charge of \$8.

4. **Additions:** Additions and improvements to the FrontPageAgent.com product will be included in your monthly Membership Fees.

5. **Initiation Fee:** Your one-time Initiation Fee includes the initial design and setup of your site.

6. **Cancellation Policy:** If you cancel your Membership Agreement within three business days you will receive a full refund. Signed written notice of cancellation must be received within this period. After this period, we are under no obligation to return any portion of your Initiation Fee. 8. **Activation:** We will activate your site within 3 days of sign up. *note: We assume no responsibility if domain registration or transfer is held up by Network Solutions or prior domain handler.*

9. **Monthly Fees:** We will automatically charge your credit card for the first and last months membership fees. Monthly Membership Fees will then be due and payable the first day of each succeeding month following the first full month your site has been activated. We will automatically charge your credit card. Your site may be deactivated if your fees are not paid within 15 days of the due date. A \$25 fee will be charged for non-payment or insufficient funds.

10. **Term:** FrontPageAgent.com sites are for a minimum term of 12 months. After your site is activated and in effect for 12 months, you may terminate your membership with a 30-day signed written notice. Written notice of termination must be faxed to 1.863.299.8682.
